For your information, some rules of the statutes of the EFA:

Art. 8

The congress is the highest authority of the EFA.

It shall be composed of

- up to two representatives per member association
- the members of the presidium

The ordinary congress shall be held in conjunction with a major EFA event usually every 2 years.

An extraordinary congress may be convened by the presidium of the EFA at any time.

Art. 9

Each member association present at the congress and the members of the presidium are entitled to vote.

The votes of the member associations are counted twice.

Art. 12

Requests to the congress to ask:

- the presidium
